## GENERALS PROVISIONS OF RENT

### Article 1 : booking and payment

Any reservation implies acceptance of internal regulation of the municipal campsite of Le Tindio \*\*\* and conditions of sale expressed below.

All rentals are personal and cannot be assigned or sublet. In case of dispute the court alone is competent valves. The reservation is effective upon signing of the reservation, confirmation and receipt of the deposit and cancellation insurance by the manager.

- Booking: deposit of 20% of the amount of the by credit card or bank transfer.
- Arrival: cashing in the balance of the stay and tourist tax (due by day and by person 18 years and over) and delivery of invoice. Presentation of deposit (150 €) uncashed, to cover damages during the stay. Inventory made by you.
- Departure: inventory made in your presence. Return of the deposit if the accommodation is left in the state. Possibility of removing a part of the amount in case of rehabilitation required. The deposit will be returned by bank transfert.

### Article 2 : cancellation of a booked stay

- Give us written confirmation (by mail)
- Without written confirmation, payment in full of the stay remaining
- In case of cancellation, rental costs and insurance remain du as compensation for breach of contract. If you cancel your stay more than 30 days before the arrival, the deposit is lost. If you cancel your stay les than 31 days before the arrival, or if you don't show up at the arrival, payment in full of the stay remaining.
- To compensate these risks, the campsite propose a cancellation insurance. This insurance must be taken with the booking. This will contract will refund you the breach of contract, according to insurance's terms.
- Therefore if you decide not to purchase cancellation insurance, you agree not to seek repayment in the event of cancellation stay. The full of stay is integrally payable at the arrival. No reduction will be accept in case of later arrival or anticipate departure.

### Article 3 : hours of departures and arrivals

Arrival after 3pm and departure before 10am.

In case of later arrival, thank to inform the reception as soon as possible

### Article 4 : Pets

Our pets are allowed in our rentals (for a charge of 4,80€ by day and by animal)Animals from France will be tattooed (or carrying an electronic transponder) and be a leash in the campsite. The second category dogs ( Rottweiler, American Staffordshire terrier with pedigree, Tosa and Staffordshire terrier with pedigree) should be vaccinated ( rabies valid ) , leashed and muzzled in the campsite . The vaccination and licensing of detention will be requested upon arrival. Dogs first categories are forbidden in campsite. Animals from other Member States of the European Union, must be tattooed or carrying a transponder. The European passport blue color will be asked you completed by a veterinarian of the country of origin arrival, confirming the identification of the animal and its vaccination against rabies.
